Russell L. Colling Literary Achievement Medal

Honoring Russell L. Colling, CHPA, Founding Member, Charter Member, first President of the International Association for Healthcare Security and Safety, and author of numerous texts and articles on healthcare security.

Presented to an individual who, through his/her literary abilities, has made a significant contribution to the healthcare security, safety, and/or risk management professions.

Literary achievements for which individuals will be considered for recognition include but are not limited to:

- Authorship of articles in publications of IAHSS and other recognized professional and industry organizations
- Authorship of an industry-related text having overall impact on the healthcare security, safety, and/or risk management profession
- Presentation of a significant industry-related subject at a professional or trade seminar and/or educational or training program

When more than one work by an author is submitted for consideration, recognition will be based upon total content rather than the number of works published or presentations made.

When literary works are the product of collaboration between two or more authors, each individual will be considered for recognition.

Nomination Criteria

Nominations may be submitted by any member in good standing of IAHSS, an executive of a healthcare facility/institution, or contract security provider employing an IAHSS member in good standing.

To be considered, nominations must be received by the Nomination Review Committee *no later than* January 15 of each year:

Nominations must specifically define the demonstrated professional contributions to healthcare security, safety, and/or risk management achieved through the efforts of the nominee.

Materials supporting nomination must include the name and business address of the nominee as well as identification of local media outlets.

All documentation and materials supporting the nomination become property of IHSSF and will not be returned.

Nomination Review Committee

The IHSSF President shall appoint a Nomination Review Committee annually. The Committee shall be comprised of at least three persons including the Committee Chairperson. Committee members shall be active or Life members in good standing of IAHSS. At least one member shall be an Officer of the seated IHSSF Board of Directors.

Recognition shall be granted without regard to race, creed, gender, national origin, or age. Recognition will be based solely upon the documentation provided with the nomination.

Nominee Selection

In accordance with procedures established by the IHSSF Board of Directors, the Nomination Review Committee shall select the most qualified as recipient of the Russell L. Colling Literary Achievement Medal. Selection will be finalized in late March.

The determinations and decisions of the Nomination Review Committee are final, based solely upon the submitted nomination documentation and supporting materials. The Nomination Review Committee will not divulge, nor discuss, with nominees, nominators, or other persons information regarding the selection of the recipient.

Recognition will not be provided if the Nomination Review Committee determines that established criteria has not been met.

In early April, the President of IHSSF will be notified by the Committee Chairperson of the decision of the Nomination Review Committee. The IHSSF President will, by formal business correspondence, notify the selected recipient, provide the specific nature of that recognition, and provide an invitation to the IAHSS event at which the recipient will be formally recognized.

The Chairperson of the Nominating Review Committee will submit a press release to the identified local media outlets as well as the chief executive officer and media relations officers of the selected recipient's facility, if appropriate. This information will be provided to be released within five days prior/subsequent to the scheduled event of recognition.
